4) APPROVAL of MINUTES of November 10, 2018 Delegate Assembly #2



# It was moved and seconded (Zelatrice Fowler, Arizona ABSE/Gloria Noland, Ohio ABSE) to accept the minutes of November 10, 2018 Delegate Assembly #2.

5) <u>President's Report</u>: President McFarland discussed the "State of NABSE" as well as NABSE's BIG 6 Priorities from the Strategic Visioning Summit:

<u>Priority 1</u>: Promote student achievement focused on programming designed to eliminate the achievement gap, increase access to early childhood educational programs and increase student success in STEM disciplines.

<u>Priority 2</u>: Implement leadership development programming and career advancement initiatives.

**Priority 3**: Establish educator recognition programs designed to highlight the exceptional.

**<u>Priority 4</u>**: Emphasize the importance of legislative involvement.

<u>Priority 5</u>: Continue to support current research and publishing efforts while also developing the infrastructure to serve as a best practice clearing house for the education of all students, but especially students of African descent.

**<u>Priority 6</u>**: Intentionally design a new economic model that ensures long-term sustainability.

- 6) <u>President-Elect's Report</u>: Dr. Nardos King, *President-Elect* highlighted Conference 2019 Attedees totaling 1150; that NABSE should be leaving the annual conference with no additional debt; she offered her "THANKS" to NABSERers for their support. Dr. King also congratulated and thanked Dr. Duana Kindle for her service and work towards making the 2019 NABSE Dallas Conference & AGM a success. Dr. King also updated delegates on the 2020 NABSE San Diego Conference & AGM with which NABSE is in contract discussion with a venue. She further detailed the 2021 Conference selection as Fort Worth, Texas.
- 7) <u>Treasurer's Report</u>: Mr. Earl Rickman delivered key topics on the 2019 Budget update/highlights as well as citing preliminary budget details for 2020. He further elaborated on the financial reports with total projected possible net gain of \$114,142.00. Proposed 2020 Income total of \$1,267,853.00 and offered that the full financial documents are made available on NABSE's website. Also, once again, introduced members of the Audit Committee.

It was moved and seconded (Deborah Hunter-Harvill, Metro Detroit ABSE/Bonnie Rateree, Harvey, Illinois) to receive the Proposed Budget for 2020.

Friendly Amendment to the Motion (Dr. Andre Hornsby - Moved/Ms. Shawn McKay - Seconded): To add a budget line Item for the Commissions of \$1,500 per Commission.

8) OLD BUSINESS:

Current & Past Financing Efforts for NABSE's Building Site: 310 Pennsylvania Avenue, DC: President McFarland gave an overview of the current and past financing efforts; for 310 Pennsylvania Avenue including currently \$3M in debt with \$1.7M Interest-Only Loan coming

due in full on November 30, 2019; and \$1.2M in aging debt. He also elaborated on the sacrifices as well as the successes of NABSE's Past Presidents.

- a) President's Recommendation asking for a motion from NABSE's Delegate Assembly in regards to the possible sale of the NABSE Headquarters building site.

It was moved and seconded (Roosevelt Nivens/Dr. Dana T. Bedden) to approve the recommendation made by President McFarland to sell the property of 310 Pennsylvania Avenue and locate a new NABSE Office in the District of Columbia (DC) area.
